LAURA AND EDUARDO ORTIZ DE LANDÁZURI

ALWAYS UNITED

The Dicastery for the Causes of Saints has authorized the request of the Archbishop of Pamplona for the transfer of the remains of the Servants of God Laura and Eduardo Ortiz de Landázuri from the cemetery to the small oratory of the University of Navarre Hospital. This was on the initiative of the postulation of the Cause of Canonization. Our Lord taught: *"What God has joined together, let no man put asunder"* (Matthew 19:5). Laura and Eduardo were united in marriage before God: so they lived their entire lives, and so they rest in expectation of eternal life.

The transfer will make it easier for the devotees of this couple to have recourse to their intercession. In addition, the chosen place has a special significance, since Eduardo played an active part in the origins of the University of Navarre Hospital and he also died there. His wife often accompanied him to the Hospital, where he received medical treatment and frequently prayed in this oratory.

An architectural firm has designed a discreet and elegant layout and lighting that does not alter the design of the oratory, nor the centrality of the tabernacle and the crucifix that preside over this chapel.

The graces that God grants through the intercession of the Servants of God are proof of their reputation for holiness. In the case of Laura and Eduardo, many of the faithful come to them to ask for favours, especially in the area of family matters and the recovery of their health.

I usually ask for favours together with one or two other people to whom I send the prayer every day so that they can say it with me as we pray. **Since I started asking these Servants of God for their intercession**, praying specifically for women who wanted to become pregnant but were unable to conceive, **they have helped us in 12 pregnancies**. I already reported on the first two pregnancies and now I am reporting on the other 10 that have been granted within the requested period, so I consider that the Ortiz de Landázuri couple has interceded before the Lord to help us **NA (Spain)**

A family of doctors

In my family there is a tradition of doctors: my grandfather, my uncle, my brother and now my nephew. Don Eduardo had written my uncle a brief and affectionate letter when my grandfather passed away, as he had known him in Granada during the 1940s. I have a copy of that letter and these days I have had it at hand in order to ask Don Eduardo for his intercession so that my nephew would be admitted to the Faculty of Medicine.

His intercession was effective. My nephew needed to be awarded a scholarship to be able to do this, since he is the sixth in a family of 10 siblings and his parents cannot afford to pay his tuition and residency fees.

He had applied for a scholarship from the university, but he was short by a few tenths of a point. From that moment on **I began to pray daily** the prayer card for private devotion to the Ortiz de Landázuri couple. Laura and Eduardo, as parents, would understand the situation well and intercede to find a good solution.

A couple of weeks later he was informed that the scholarship had been granted. **MMA (Spain)**
